Who should redevelopment of this area serve?

The land should be sold to private developers, subject to a clearly defined City plan for sites within the BOA, and an expedited regulatory approval process, so as to ensure that new development supports overall project goals and occurs expeditiously. Given the City's long-running fiscal challenges and the unique market appeal of development sites along the riverfront, lands within the BOA should generally not be sold to tax-exempt entities, nor be sold to real estate speculators. All prospective buyers should be required to project both the property tax contributions and the cost of providing City *and* NECSD services to the projects they envision. Land sales should have clear and firm timelines for completion of development--and meaningful financial penalties and/or clawback provisions for developers who do not complete their projects expeditiously.

While some affordable housing should be included within the BOA, it should be woven into privately owned mixed-income developments and specifically configured (e.g., affordable senior housing) to ensure that all development within the BOA yields a net-positive revenue contribution to both the City and the NECSD. The BOA area represents far and away the best opportunity for the City to grow its tax base and is accordingly not the appropriate place for new dedicated affordable projects or other tax-exempt uses.

Create an integrated, dense, beautiful set of residential neighborhoods anchored by large scale institutional uses (one educational, one amusement/cultural, one commercial) that helps Newburgh accelerate its transformation into a self-sufficient, prosperous, safe hub for enjoying and improving the Hudson Valley, New York State, and the world.

The strategy is called WHYM: Wheel, Homes, Yard, and Market.

HOUSING

The bulk of development in the area should be, once remediation is complete, housing. On Broadway at Lander, a large-scale city-block apartment house. On side streets, multi-family townhomes. Each individual development will adhere to five-minute neighborhood standards and integrated green space. Green and solar roofs, no minimum parking requirements, variegated inclusion of single-family homes, community gardens, and other best practices for smart growth will be required. Design standards would be development-specific, but in general aspects of the Historic District code requirements would be suspended for new construction and eased for renovations to existing structures, while maintaining complementary visual aesthetics and appeal, to create a new Newburgh architectural vernacular.

Housing access and subsidy would be granted, in order and according to various formulated rules, to those categories listed in Question 5. Occupancy will be tied to the building of generational wealth. For example, cooperative or outright ownership structures may be preferred. In rental scenarios, individual "housing savings accounts" will be established so that a government or privately matched portion of monthly rent is invested for the renter to accumulate over time.

Crucially, the neighborhoods thus built out would be connected by continuous free shuttle service to the anchor institutional uses, the length of Broadway (potentially as far as Stewart Airport), Delano-Hitch Park, and Downing Park.

INSTITUTIONAL USES

CULTURAL/AMUSEMENT: The City will contract with a firm that designs and installs large-scale ferris wheel attractions, such as those in London, Moscow, and Dubai. The Hudson Eye would rise from the hillside just east of SUNY Orange, leaving the views down Broadway and from the Ebenezer Baptist Church intact. Ticketing, queues, interpretative materials, refreshments stands, shade, seating, etc., will be via Clinton Square. Construction hiring preference for appropriate jobs will be granted to qualified permanent City residents. During construction an attractions management firm will create a recruitment/educational program for the management and operation of this publicly-owned attraction (perhaps Merlin Entertainments, which operates the London Eye and Legoland, would incorporate into their current training). Management and all operations positions will be filled by the City of Newburgh residents who are trained during this program, which will be ongoing once the attraction is generating revenue. Employment at the Eye would be academically tied to Hospitality Management programs of regional colleges and universities. Locals ride free with some tickets reserved for the purpose according to various timing/availability criteria.

EDUCATIONAL/SKILL-BUILDING: The State of New York will transform the waterfront brownfield south of the Public Boat Launch into a multi-discipline, human-scale boatyard. This center for the design, construction, maintenance, and education for the building and management of wooden and other "light" boats and water-based livelihood would be an all-trades center, with tie-ins to other local industrial incubators and skills centers including BOCES, SUNY Orange, the Culinary Institute, etc. Echoing the Ptech model, students could engage in the Center during high school and emerge with an Associates degree, with academic accrediation from SUNY Orange and from the Merchant Marine Academy as well as buildings trades unions, and the US Navy.

COMMERCIAL: The Dutch Reformed Church would be rescued and turned into the city's primary four-seasons public market, offering primarily local and New York State produced produce, processed and preserved food and beverages, as well as locally-produced durable goods, printed materials, etc. As with each initiative, the Market would be restored via contractors chosen by state procurement rules, with local hiring preference, and a recruitment and training program for market management and operations would be run by a markets management entity (commercial or academic) within SUNY Orange during construction. Management and operations staff would be chosen from trainees in this program.

Are there specific locations that are a priority to you?

1) The hillside parcels just east of SUNY Orange and Clinton Square; 2) the Dutch Reformed Church; 3) the waterfront brownfield just east of the public boat launch. These are the anchor points for the programmatic approach, in combination with housing, pedestrian-focused streetscaping, and policy, that comprise the strategy.

One strength of this admittedly ambitious proposal is how it is meant to integrate with the living City and how its parts interrelate. Picture this: a train pulls into Beacon, and four locally constructed skiffs, crewed by highly-trained, unionized Newburgh teens, await to take paying passengers across the river where they disembark for the short walk or shuttle to Clinton Square to get a snack and wait their turn to ride the Hudson Eye. After experiencing the exhilarating view, during which they have been accommodated and guided by local staff and operators, they visit the Newburgh Public Market, on a par with any such establishment in New York City, and where they can indulge in local and regional food, beverages, crafts and culture, before dining out, lodging, or continuing on to another destination.

It sounds like a tourism story, but it's not just that. Tourism is a sustainable practice ground and revenue generating platform for the true work of a city: housing and connecting people in safety and joy so they can enjoy the world and improve the world. To bring the tourist experience above to life, local residents will have been recruited, trained, employed, and inspired across multiple disciplines, livelihoods, and ways of living -- the foundations for continuing to build society and civilization while living well. The Market and the Wheel, and the skills, stories and recreational sailing and fishing of the Yard, are all there for the residents too; they are not absent from these amenities, but central to them, when the visitors have left.

Roughly, I want to see the hillside restored to what it was. The more "cozy" and tight we can make the streets and alleys, the more unique it would be. There should certainly be some public green space for sure.

I believe we need some kind of mode of transportation from the waterfront to Broadway. I personally favor a funicular people could ride. Similar to what Lisbon uses for similar steep grades. I hope that one day there is a median and some kind of mass transportation on broadway. A cheaper alternative might be some kind of system I've seen at mountain biking resorts that can pull a bike up the hill.

For the empty lots on broadway, I would like to see as much housing as possible with commercial on the bottom floors. I'm down with a super high building on the mid broadway lot.

Finally, I think it would be critical to build a huge parking garage on the Ann St lot. It could have commercial space on the bottom, but it's a perfect location for liberty street and future broadway traffic. What I don't want to see is a parking garage on the waterfront, or as little parking as possible on the hillside unless it's buried underneath. And if there was some kind of trolley, funicular, or even a mini bus or something that took people from the Ann St lot to the hillside that would be great. The trolley system used in Istanbul is what I'm imagining there. Let it run from the top of broadway to the bottom, then wind through the hillside, across or under the train, and along the waterfront connecting the science museum to hopeful future development at Regal Bag, up the hill, and up broadway. Eventually it would be great to have the trolley run along liberty, S William, Carpenter to connect Delano Hitch, Downing Park, etc.

There is so much potential for this area it's hard to know where to begin. If re-development is done right and responsibly, Newburgh could be the Jewel of the Hudson again. I've worked in Newburgh for six years (and lived in the city for a time) and the more I learn about the city's history the more I lament what was lost and hope for what could be. As I'm sure the reader is aware the study area encompasses the part of the city that was hit hardest by Urban Renewal. During Urban Renewal, half the most densified part of the city was demolished. The hill between Colden Street and Water street used to be home to bustling and architecturally-diverse neighborhoods. Demolishing this area specifically "decapitated" the city to use city historian, Mary McTamaney's words. Getting off the ferry today, where you were once greeted with store fronts, shops, and winding city streets in the European-style, you are now greeted by parking lots. A desert of asphalt now covers what was once the most vibrant part of the city. All those parking lots north of Hudson Taco- which sit unused most of the year- lay where buildings once stood. Urban renewal destroyed so much of Newburgh's cultural heritage, but there is hope for this historical wrong to be righted. This survey is a good start. There is hope in that much of the area within the study area has remained undeveloped since the days of Urban Renewal. This leaves us with a blank slate on which to build anew, but it's so important we do it right. Thankfully no cookie-cutter, vinyl-sided, mono-developments have gone up in the area between Colden and Water street. Any future development of this area should be architecturally diverse, reflecting styles that both honor what once stood in that area while at the same time celebrating and incorporating the stunning views that hillside offers. I respect the Kearney group's interest and efficacy in restoration and building mixed used developments in distressed areas, but I find their architectural style bland. The neighborhoods that are rebuilt in this area should reflect a pride of place and a pride of architectureit may not be the cheaper option, but it will be the better long term option in terms of re-vitalizing the city and creating a model for the rest of the country to follow in cities also devastated by Urban renewal. Regarding the guestion of housing justice, this is a trickier one to answer, but I have some ideas. It is my understanding that the Kearney group is offering a "right of return" policy to any city residents who wish to rent an apartment in their new development going in on the old Smith Street. This policy essentially gives descendants of those negatively affected by Urban Renewal right of "first dibs" when applying to an apartment in the Kearney complex. While this policy is a good start, and definitely better than nothing. I have to agree with some residents' criticism that it is a slap in the face to those families who used to own properties taken by Urban Renewal. That is why I recommend that any future development include an option to own for descendants of those negatively affected by Urban Renewal. The way this could be done is to portion of a section of the study area into moderately-sized residential parcels, and then offer to sell those parcels at at belowmarket-rate to descendants of those negatively affected by urban renewal. Proofs of former ownership on Urban Renewal land would be required. It's not lost on me that a program such as this would require funding, but this objective is not without precedent. The Newburgh Community Land Bank has been rehabing vacant and derelict properties for years and offering them to city residents at below market rate. Rupco also just finished its East-End project in which it built properties to be rented on former empty lots. Funding is available and I think with a little political will and creativity this could be done. And, with the appetite for reparations, it could serve as a model for other areas of the country.

What should the goals for this area be?

The revitalization of Newburgh. The "head" of the city must be returned to the "body." In order for the city to revitalize four main things need to happen:

- 1. Responsible Re-development of the Water Front (especially Colden and Water Streets)
- 2. Better Public Transportation (including weekend ferry service, bike infrastructure, and service up hill to Broadway).
- 3. Grocery store on Main (Broadway or Potentially new development needs to include a full-service grocery store within walking distance to city residents)
- 4. NO MORE PARKING LOTS! (Please don't be fooled by those city residents always complaining about there not being enough parking. This drives me crazy. The city of Newburgh is still less populace than it was in 1960. If people back then made it work (with even less parking and more residential density), we can make it work today. There are too many parking lots in Newburgh that just sit empty most of the year, where there was once commercial or residential spaces. Granted, I understand people needing a car to get groceries. That is why a grocery store on main is needed.

Q3

Increased ferry service and a development that invites people into the city is paramount. Newburgh's downtown needs to be reconnected to the waterfront. With increased ferry service tourists and residents should be greeted by a civil design that invites them up the hill into the city proper. Right now, once is confronted by an intimidating parking lot and freight line when you get off the ferry. The NY Waterways CEO recently announced that they may be doing weekend service on their "Northern Routes" which includes the Newburgh Beacon Ferry. This, in conjunction with the fact that the Fjord Trail is scheduled to be completed by 2030, represents a real opportunity for Newburgh to attract more foot traffic to the city in future years.

The hill between Colden and Water streets. The Old Colden street used to gradually slope down to Clinton Square where it connected with the Waterfront. I would love to see a development which restores this connection. Also, this should coincide with some form of public transportation that would shuttle residents from the waterfront, up the hill, to points along Broadway- not unlike the Beacon Free loop bus across the river. Personally, I favor the restoration of the electric trolley that once carried passengers from the waterfront up the Old Colden Street. The old trolley line in Newburgh ran all the way down Broadway as far out to Orange Lake, and it connected to other Trolley lines on Liberty and South street. I know this may sound like a pie-in-the-sky idea, but it is also not without precedent. The city of El Paso, Texas recently restored their old electric trolley lines. It's also an opportunity for Newburgh to embrace its history as one of the first cities in the country to be electrified, and invest in our new era of electrification going into the 21st century- taking the lead again and setting an example for other municipalities across the country. I think it would at least be worth looking into a funicular trolley design to shuttle passengers up the hill from the waterfront.

Specific examples include reconnecting the BOA to the existing downtown street grid, rightsizing NYSDOT Water Street to be pedestrian, rightsizing Broadway to be a walkable/bikable boulevard, implementing a pedestrian, bicycling masterplan (over parking lots like on Water and Front St, new buildings to have parking behind the building or underground), specific commercial corridors that have retail but also space for buses, wide enough sidewalks for street furniture and available public EV charging stations. Build out human scale (at least 50% of the 1300 parcels, 5-8 story high, utilitarian rooftops for tenants, buildings with stepped form to enhance view shed, and activated street corners.

The next public session should outline the 10+ nodes to dig deeper into the opportunities in the landscape. A quick quick sketch shows the following nodes:

- 9. Waterfront from Boat Launch via Ferry Marina Unico park to Regal Bag

This should NOT become a high rise, luxury condo infestation. The descendants of Urban Renewal should also be part of the planning and receive benefits. Their families should receive a portion of tax revenue from this block, to ensure generational wealth.

I can tell you what I don't want to see. Large skyscraper buildings that block the views of the Hudson River and Mount Beacon. There should be beautiful, brick buildings to match the historical ambiance of the city. I want trees to be planted on the Waterfront Trail (near the boat launch). The city decided to rip up trees, but with all of the flooding and natural disasters occurring we will need vegetation to keep us safe. Billy Joes gets flooded constantly. Development will become irrelevant if we do not ensure our environment is stable and able to thrive. There should also be ease of recycling and trash cans on the streets. You may notice there is a lack of trash cans on the streets on Newburgh....

I currently live on Broadway, but outside the perimeter. I would like to see Broadway connected to the waterfront in a more accessible way. With bike lanes or walkways that are easy for people in wheelchairs to use.

Who should redevelopment of this area serve?

People within the community. Priority should go to those who have shown positive intentions in the city, not just those who want to gentrify it. It should NOT go to Seraphim Equities. They thrive off gentrification and playing monopoly with buildings in distressed cities. They hoard properties and literally pay for people to leave the city of Newburgh. The owner of Seraphim has a podcast called "How to flip an entire town & revitalize it too." I question what their definition of "revitalization" is. I imagine it includes cleansing the city of Newburgh of its original residents. There should be training/workforce opportunities available for local residents to get into the construction trade and get paid for revitalizing the city. I am aware there is a housing crisis. Instead of building new construction on the water front, funds could be used to help bring these existing homes into shape. Let's keep the quaintness of Newburgh. We don't need more housing, we need to update the ones that have been abandoned.

I was told there will be a process to survey the land for contamination. If contamination is found, it is important to make sure we properly dispose of any toxins. We do not want to further harm the health of Newburgh residents, who have already been compromised by Stewart National Air Base. I would also like to reinforce the needs for reparations for the decedents of Urban Renewal. There should be an equitable and wealth building opportunity for those families. Any new development or rehabilitation should also be energy efficient and electrified. NO natural gas or fossil fuels. There is also a severe addiction crisis in this city. There are used needles all over the streets. These people need help & services to turn their life around. This can be next to the urgent care centers I mentioned in one of the previous questions.

Newburgh deserves the reconstitution of a dense cityscape, in the mixed-use mode of our former Waterfront District. Streetscapes of 3-6 story buildings, centered on ground floor retail and upper-story residential, with larger commercial and green anchors sited throughout the 144-acre development area. A limited focus on parking, with a requisite number of municipal decked or underground garages as at SUNY Orange, and a central focus on a ferry terminal and greater bus and 'very-light-rail' service linking the full Broadway corridor.

Q2

What should the goals for this area be?

- 1. Re-establish the street grid to reconnect the entire city while gaining access to more buildable parcels as they existed before 1974.
- 2. Human-scale development patterns rather than monolithic development -- A design district board should be created with an urban design excellence mandate to review all development proposals alongside Planning and Zoning.
- 3. Formalize right to return policy for those displaced by Newburgh Urban Renewal and establish land sale, unit ownership, and tenancy prioritizations for long-time Newburgh residents and minority communities.

Q3

What kind of development would you like to see happen in this area? Where?

Dense and human-scaled development, 3-6 stories with hundreds of distinct buildings -- categorically not mega blocks as on the Yonkers waterfront. While we'll never regain the 1,400 lost structures, we should evaluate minimum viable lot size for development, plot those parcels, and encourage an organic development pattern, fast-tracking the way cities naturally grow and are varies, while also reducing the risk involved with only a few large developments.

Are there specific locations that are a priority to you?

- 1. Broadway: Terraced for pedestrian access all the way to the Hudson and involve a light or very-light-rail system traveling up to Stewart. The ferry and a waterfront park, like Beacon's Long Dock, at the base.
- 2. Hudson Waterfront: Scenic Hudson's Long Dock Park is a model to be emulated in Newburgh, with a connected bike and pedestrian trail to the Newburgh-Beacon bridge and ample parkland along the river itself.

Who should redevelopment of this area serve?

The entire City must be served. We have the great fortune to have the immense rail trestle which allows our waterfront to be fully connected to the upper city. With a reconstituted street grid, retail, and green spaces, these currently broken apart parts of a whole Newburgh can be used by everyone, especially the riverfront.

Are there any additional thoughts or comments you'd like to share?

We have a wealth of mapping and photographic evidence for the destroyed city -- We must lay these future plans with an informed view of the past, especially when creating new parcel boundaries that encouraging development of anchor institutions, be they cultural, lodging, retail, or non-profit, in urban geographies such as Clinton Square and Lower Broadway. Crucially, we'l need congressional and gubernatorial support back re-building against the rail trestle, once the very dense East side of Water Street with our largest department stores, and the West side of Front Street and the densest core of the riverfront.

I'm Carson Carter, I sit on the ARC and Historical Society boards and am involved in my own preservation project and several non-profit initiatives centered on Newburgh's built environment. I live on First Street at Liberty and each morning I walk down to the dead end of my block, overlooking the Hudson, and what was once a thru street cutting past Clinton Square, the very center of old Newburgh. Every single day, I think about the destruction wrought upon Newburgh and its people. I also think about the city we're rebuilding and the unparalleled opportunity, unencumbered by freeways or massive government plazas, to again make these hillsides dense, livable, and once again part of this extraordinary little city overlooking Newburgh Bay.

As a result, the new construction was ugly, sterile, and unfriendly. But the city decided to do something different in the 21st century, and redesigned the fronts of the buildings, decorating them with facades to fit the way the city used to look before the war. The additional cost for this aesthetic uplift only cost 3-5% of the total cost spent to construct the buildings. And the economic effects were amazing! The designs brought in tourism because it created a space where people actually wanted to be.

Understanding it will never look quite the same as it once did, it doesn't mean Newburgh should resort to cheap, soulless builds. Newburgh is architecturally significant, it should be used to its advantage! Newburgh's rebound doesn't have to be boring, it can be a unique and inspiring story of a city that chose to do something special.

Dense, mixed use development. I want to see homes and businesses on top of one another, coexisting.

Yet we do need to balance generation of tax revenue with preserving the viewshed; it is essential to have some open space. We don't need to develop every square inch of the hillside.

First, I am extremely wary of large development projects. All too often they end up not as they started, and if several large companies end up with the job there are always grumbles and accusations about favoritism, whether true or not. I would much rather see the land divided into normal sized lots with allocations for residential and mixed used buildings, with a setting aside of green space. It would be exciting-- rather than pbeing told that some corporation was building some attraction or hotel, locals would be developing it ourselves. As it should be.

I would only say that it is important to preserve the viewshed. It would be a terrible mistake to cut off the riverfront with a wall of six or eight story condo buildings. It would be an equally grave mistake to make some project that is more accessible from the river side of the area than the City side.

Yes! Set aside a certain number of lots to be sold by the city to city residents on generous terms on a lottery basis. Proof that your family lost land in urban renewal would gain, say 20 entries. Winners of the lottery would be allowed to purchase a parcel from the city on a basis where the city holds the mortgage or some other generous arrangement. The city could partner with local developers and local banks to enable construction loans and construction. It would be a path to home ownership while addressing equity concerns.

They will look at an idealistic View and we'll have a fresh take on incorporating historical aspects with modern thoughts of design.

Well I grew up in Orange County and lived in a town just a 20-minute drive from the downtown area in question. I remember as a very young child going my father through different restaurants and bars in the 70s and 80s because he was a restaurant supply salesman. I also remember traveling to the Newburgh Free Library often throughout High School whenever I had a report or subject I need to study. Because the Newburgh Library was always drastically Superior than my local little library at the time. Not only offering more materials but also a better place to spread out and study and to do school work. Sometimes I remember the library is waiting with me after the library would close because my parents may have been slightly late to pick me up. And they didn't want to leave me alone. Although the area may have not been the nicest I often would find myself staring at the buildings that I saw in disarray as well as the ones that were still habited. Probably develop my love of architecture I often visiting this area. I ended up going to Orange County Community College for architecture. I spent a lot of time in that Newburgh area by the Waterfront with friends who would launch both of the summer times. When I turn 18 and graduated high school I worked at a restaurant on the waterfront in the kitchen, in the summer times and weekends during school year while I attended occ. And then I would spend even more time once I turn 21 at the local Waterfront, and other establishments visiting the various bars and clubs that we would go to on the weekends. I'm quite certain that the historical architecture of the region influenced me a great deal because I have a love for maintaining historical buildings which let me go into architecture and then into engineering.

Give you an example of how much of a respect I developed for historical architecture. My firm had been contracted for the sprucing up and updating the 1887 County building. Adding handicap accessible entrances in addition to painting and other upgrades to it. The original plan called for replacing the entryways with handicap ramps and self opening and closing doors, completely replacing the beautiful historical bronze doors that are there now. I was lucky enough to start working at that firm early in the project when it was given to me take over. And I found a way to keep the original doors which everybody who work there was complaining about because they're so difficult to open, and were the first things that they wanted us to get rid of. I found people who specialized in Hardware and modernizing such antique entrances and was able to meet the needs for everybody as well as figure out a way to make a handicap entrance without altering the existing entryways. Not the two my own home but I'm the reason why those bronze doors are still there today and not in storage now, which they're actually was a specific Place marked out and a structure to be designed where they were going to be stored in a basement.

I went to school for architecture at Orange Community college, worked for an architect in the area for 8 years, ended up migrating to an engineering firm in Rockland County for 14 years and completed my associates in engineering down at Rockland community college. I'm also certified as a New York State Building Code official maintaining my certification in New York State Building Code and Fire safety. And I currently live in Monroe New york. St. Mary hopefully emerging from its protective cocoon and engaging with the rest of the community. They need to be enabled to go after the slumlords and tax evaders - not the low hanging fruit of pestering people out of the city and engendering ill will toward redevelopment and rebuilding of this city.

Equitable, inclusive, meaning people who can pay taxes, those who can't, those who can't now but with jobs will, renters, owners -- a compassionate city where everyone is welcome and planning is financially, socially and environmentally sustainable. From water street and above, the streets and grid should be returned as close as possible to the original plan, with design for public transportation, bike and pedestrian walkability and parking garages should be underground and in the center of buildings (hidden but plentiful). Along water street should also be as much commercial retail on the first floor, intermixed with office above and high end residential above that. On the streets above Water street, there should be a mix of residential, particularly live-work units where residents can be allowed to have offices or businesses on the first floor. Design of these buildings should be considerate to the historic district where they reside and forward looking architecture as the rest of the district was designed in its time. Of course, employing green building principles and passive house where possible. The waterfront needs to be planned appropriately to maximize the unique benefits of our section of the Hudson and deep water to put in additional water access that almost none of the other Hudson River towns have, but the ones who do, get great use of (deep water anchorage, docks etc).

Are there specific locations that are a priority to you?

All of it, but certainly any land with water views (should be the highest priced and highest taxed). Consolidated Iron needs to be planned and pursued appropriately so as to encourage the commensurate infill development on private parcels along the water. There needs to be a strong plan and then a concerted proactive effort to pursue the developers who will enact the plan, not a "just wait and see / luck to get what we get" approach from the development world. I can not reiterate enough the value and appropriateness of the DPZ Andres Duany Plan. And an attempt to get the firm back to update and address current conditions would be invaluable.

The commercial should serve not only the existing Newburgh community, but encourage new residents (with new dollars) and tourists / visitors (also new dollars). The residential, again, should be for whoever can afford the market rate views and pay the market rate taxes to help bolster the city's tax rolls and hopefully create a budget to take care of the amenities and services we already have but are underfunded and lighten the every heavy tax burden on the existing Newburgher's who are fighting everyday to be able to keep their homes in the face of disproportionate taxes. It should NOT be restricted or designated to any special interest group, race religion or any other designation. Free market, market rate with a market standard of affordable intermixed.

Are there any additional thoughts or comments you'd like to share?

I am obviously concerned about appropriate and well thought out planning for the future of the city and its sustainability. The city's built and social fabric has suffered long enough from the bad planning of urban renewal. The original footprint was intelligent and beautiful and well used. I am in favor of a plan that brings back that glory and that level of amenity, diversity and community. That includes and encourages small businesses and locals and visitors, that is not artificially sustained through programs that larger government has to subsidize or support. We have a jewel and it should shine and valued as such. The city is large enough for everyone who wants to be here. There are appropriate places for all uses, as demonstrated by years and years of great historic planning and successful (economically and socially) cities. Let's look to our past and great examples to show us how to stand on our own feet and respect where we have come from and we all have the potential to go, in a safe and beautiful environment. Also, just a side note, if there is any modern way to bring back the concept of the trolley and certainly any historic nods and adaptive reuse and historic renovation as there is also an immense value in the desirability, safety and community benefits to rehabbed and respected historic districts and cities.
